**A RESOLUTION OF CHAIR AND BOARD OF DIRECTORS
OF THE HALLANDALE BEACH COMMUNITY
REDEVELOPMENT AGENCY, HALLANDALE BEACH,
FLORIDA, REJECTING RFP #2015-2016-CRA001;
AUTHORIZING THE EXECUTIVE DIRECTOR TO RE-

WHEREAS, the Procurement Department of the City of Hallandale Beach previously issued RFP # 2015-2016-CRA001 on behalf of the the Hallandale Beach Community Redevelopment Agency (HBCRA) with respect to updating the HBCRA Implementation Plan; and

WHEREAS, in response to the RFP, the HBCRA received five (5) proposals; and

WHEREAS, the Evaluation Committee evaluated the responses from the proposers; and;

WHEREAS, after final review by the HBCRA Executive Director, it was decided that due to the drastic differences in the evaluation scores by the Evaluation Committee, it is recommended to reject the proposals and move forward with the release of a new bid; and

WHEREAS, the HBCRA Board desires to reject the proposals and move forward with the release of a new bid

NOW, THEREFORE, BE IT RESOLVED BY THE CHAIR AND BOARD OF DIRECTORS OF THE HALLANDALE BEACH COMMUNITY REDEVELOPMENT AGENCY:

Section 1. Recitals. The recitals in the whereas clauses are true and correct, and incorporated into this Resolution.

Section 2. Rejection of RFP # 2015-2016-CRA001. All of the proposals received in response to RFP # 2015-2016-CRA001 are hereby rejected.

Section 3. Re-advertise RFP # 2015-2016-CRA001. The HBCRA Executive Director is hereby authorized to re-advertise the RFP # 2015-2016-CRA001.


Section 4. Effective Date. This resolution shall take effect immediately upon approval.
