



35 the year, the City had multiple settlements totaling \$1,122,416. The  
36 amendment to the FY 2018-19 Budget will not exceed \$400,000; and

37 **WHEREAS**, this budget amendment will amend the FY 2018-2019 adopted budget  
38 as indicated in Attachment A of this ordinance; and

39  
40 **WHEREAS**, the Mayor and City Commission have determined that it is in the best  
41 interest of the City and its residents to amend the FY 2018-2019 adopted budget as  
42 reflected in the attachment; and

43  
44 **WHEREAS**, the Mayor and City Commission have determined that this proposed  
45 budget amendment is timely under Florida Statutes 166.241 and is being adopted in the  
46 same manner as the original adoption of the FY 2018-2019 budget.

47  
48 **NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY**  
49 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

50  
51 **SECTION 1.** The foregoing "Whereas" clauses are confirmed as true and  
52 incorporated herein.

53  
54 **SECTION 2. Adoption of Budget Amendment.** The Mayor and City  
55 Commission hereby adopt the budget amendment to the FY 2018-2019 adopted budget  
56 as set forth in Attachments A of this ordinance.

57  
58 **SECTION 3. Conflict.** All ordinances, parts of ordinances, resolutions, or parts  
59 of resolutions in conflict herewith are hereby repealed, to the extent of the conflict.

60  
61 **SECTION 4. Severability.** Should any provision of this Ordinance be declared by  
62 a court of competent jurisdiction to be invalid, such decision shall not affect the validity of  
63 this Ordinance as a whole or any portion thereof, other than the part that is declared to be  
64 invalid.

65  
66 **SECTION 5. Effective Date.** This Ordinance shall take effect immediately upon  
67 adoption.




