3 A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE  
4 CITY OF HALLANDALE BEACH, FLORIDA, AWARING BID #FY2017-  
5 2018-014-001, UNIFORM PURCHASE FOR THE HALLANDALE POLICE  
6 DEPARTMENT, TO THE LOWEST BIDDER, LOU'S POLICE  
7 DISTRIBUTORS, INC. IN THE AMOUNT NOT TO EXCEED FIFTY TWO  
8 THOUSAND DOLLARS (\$52,000) ANNUALLY FOR A TOTAL COSTS  
9 NO TO EXCEED FIFTY TWO THOUSAND DOLLARS (\$52,000) FOR A  
10 FIVE (5) YEAR TERM; AND PROVIDING AN EFFECTIVE DATE .

12 WHEREAS, the City released bid solicitation and award in November 2019 for  
13 uniform purchase contract for the Hallandale Beach Police Department for two (2) types  
14 of Police uniforms; and  
15

16 WHEREAS, the City received two submitted bids from vendors Lou's Police  
17 Distributors, Inc. and Gold Nugget Uniform, Inc. dba Argo Uniform; and  
18

19 WHEREAS, staff has reviewed the two (2) bids and recommends award to the  
20 lowest responsive, responsible bidder; and  
21

22 WHEREAS, the City Administration further urges the City Commission to award  
23 the Police Uniform bid# FY 2017-2018-014-001 to the lowest bidder, Lou's Police  
24 Distributors, Inc. The award is not to exceed fifty-two thousand dollars (\$52,000) annually,  
25 for a term of five (5) years.

27 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY  
28 COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:  
29

30 **SECTION 1. City Commission Action.** The Mayor and City Commission  
31 hereby award Bid #2017-2018-014-001, for Hallandale Police Department uniform  
32 purchase to Lou's Police Distributors, Inc. as the lowest responsive, responsible bidder  
33

34 **SECTION 2. City Manager Authorization.** The Mayor and City Commission  
35 hereby authorize the City Manager to execute all related documents to effectuate the  
36 purchase with Lou's Police Distributors, Inc. in an amount not to exceed fifty-two thousand  
37 (\$52,000) dollars annually, for a five (5) year contract term.




