**A RESOLUTION OF THE MAYOR AND CITY COMMISSION
OF THE CITY OF HALLANDALE BEACH, FLORIDA,
AUTHORIZING THE CITY MANAGER TO REJECT RFP
#FY2021-2022-005 BEST USE OF FOSTER PARK
COMMUNITY CENTER; AND PROVIDING FOR AN
EFFECTIVE DATE.**

WHEREAS, on December 16, 2021, the City of Hallandale Beach released Request for Proposals (RFP) #FY2021-2022-005 BEST USE OF FOSTER PARK COMMUNITY CENTER via email to over nine hundred (900) vendors including vendors from the City's Vendor list; and

WHEREAS, on February 24, 2022, the City received one (1) response to the RFP solicitation from Figgers Communication Inc; and

WHEREAS, on March 22, 2022, the Evaluation Committee held an in-person meeting to evaluate the single proposal received; and

WHEREAS, upon the Evaluation Committee's review of the vendor's submittal of documentation with the minimum requirements of the RFP, it was unanimously determined that the vendor's submittals did not meet the minimum qualification requirements for items #2a, #2b and #2c; and

WHEREAS, pursuant to City of Hallandale Beach Code of Ordinances, Chapter 23, Section 23-12, Procedures for purchases in excess of \$50,000, (4) Rejection of Bids, the City Commission may authorize City Manager to a) reject all bids; or b) reject all bids and re-advertise, pursuant to the procedure prescribed in the Code; and

WHEREAS, City Administration seeks City Commission authorization to reject the lone submitted proposal and authorize the City Manager to re-advertise or otherwise

35 procure the requested services in compliance with the City of Hallandale Beach Code of
36 Ordinances.


48 **SECTION 3. Effective Date.** This Resolution shall take effect immediately upon
