5 **A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF**
6 **THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED**
7 **BID #FY 2021-2022-020 BUILDING DIVISION SERVICES TO**
8 **CALVIN, GIORDANO, & ASSOCIATES, INC., AS THE HIGHEST**
9 **RANKED VENDOR, AND AUTHORIZING THE CITY MANAGER**
10 **NEGOTIATE AN AGREEMENT; AND PROVIDING FOR AN**
11 **EFFECTIVE DATE.**

13 **WHEREAS**, pursuant to Chapter 23, Section 23-4, Competitive Bidding Required, all
14 purchases of and contracts for equipment, supplies and contractual services, when the estimated
15 cost shall exceed \$50,000.00, shall be based on competitive bids; and
16

17 **WHEREAS**, there is currently a national shortage of qualified Building Code Compliance
18 professionals due to the aging population and lack of institutional resources. Minor permits, such
19 as kitchen and bathroom remodels, flooring, shutters, and re-roofing, take 6-8 months, and major
20 development permits take over one year for review and permit issuance. Building inspections are
21 scheduled more than a week out; and

23 **WHEREAS**, on August 11, 2022, procurement published solicitation RFP # FY2021-2022-
24 020 for Building Division Services; and

26 **WHEREAS**, the City's selection committee met on October 11, 2022, and selected Calvin,
27 Giordano, & Associates, Inc. as the highest ranked firm. Calvin, Giordano, & Associates, Inc.;
28 and

30 **WHEREAS**, staff recommends that the Mayor and City Commission approve awarding
31 Bid # FY 2021-2022-020 Building Division Services to Calvin, Giordano, & Associates, Inc.. as
32 the highest ranked vendor and authorize the City Manager to negotiate an agreement that will be
33 brought back to the City Commission for approval.


38 **SECTION 1. Recitals.** The foregoing recitals are true and correct and incorporated


